





#### **Comments from the Chair**

Strategic Retreat at the Cherokee Nation Hotel in Catoosa – January 22-23, 2009. What a great retreat this year! Hat's off to Bill Smith and the tremendous amount of work and effort he put forth to help guide OFMA in the coming year. More details will be provided by the Executive Director in his news article on page 10.

At the OFMA Board meeting held on January 23, the long needed action to increase dues was taken. Beginning in the 2009-2010 **OFMA year** the dues will change from \$30 to \$50 per individual member, from \$100 to **\$150** for the corporate membership and from **\$50** to **\$75** for the Agency memberships. Several factors contribute to this urgent need:

- OFMA's Annual and Spring Conferences for the last three years have been consistently under funded.
- Our operational expenses have increased.
- 3. We have no paid employees.
- Expenses for web master and web site maintenance have increased.

In order to keep service levels up to standards, we need to increase our fees.

CAP (Community Assistance Program) **Meeting at FEMA – January 28-30** – Was

off to a harrowing start as Ken Morris provided safe passage down I-35 to Denton into the teeth of the ICE and SNOW Storm deposits for Gavin Brady, Ellen Steven and I. A great thanks to Ken and his wonder truck with four wheel drive and all-terrain "hunting" tires.

At the CAP meeting FEMA staff provided several items that were of note which included the "Outreach Plan for 2009", "Map MOD for several Oklahoma update **Communities regarding Post Preliminary** Process", "Risk Map", "DFIRM 101 Workshop" and a challenge by Ross Richardson FMI Branch Chief regarding a response by the Association on how to approach the issue of "Substantial Damage".

In regard to the **Region VI National Flood** Insurance Program (NFIP) Outreach Plan for 2009. This is a more aggressive Community Assistance Contacts (CAC's) and Community Assistance (CAV's) program (i.e. more visits). Staff from FEMA or from the NFIP State Coordinator's Office and/or OWRB on behalf of FEMA will visit with a community to provide technical assistance to the community and assure that the community is adequately enforcing floodplain management regulations. Oklahoma, the CAV is either performed by staff from FEMA Region VI and/or from the Oklahoma Water Resources Board NFIP Coordinator staff and usually only after a Community Assistance Contact.

A CAV is also an important and key part of the CRS (Community Rating System) program for reduced flood insurance rates and consists of a tour of the floodplain, an inspection of community permit files and meetings with local appointed and elected officials. FEMA, OWRB, and NFIP Staff (State) and OFMA workshops also assist community officials to learn about compliance with NFIP requirements. The State will work with the community to help bring their program into compliance with NFIP requirements. extreme cases where the community does not take action to bring itself into compliance, FEMA may initiate and enforce action against the community.

FEMA also outlined MAP MOD Post-Preliminary Activities which include the following fifteen (15) counties in Oklahoma:

Grady, Kingfisher, Lincoln, Sequoyah, Adair, Seminole, Caddo, Custer, Delaware, Le Flore, McCurtain, Pontotoc, Mayes, Jackson and Woodward.



We also received some updated information on the **new Risk Map Program** (see illustration on page 6) from Jack Quarles, Regional FEMA Engineer and Ramesh Cintala of the RMC. According to the FEMA website on Risk Map – it "combines flood hazard mapping, risk assessment tools and Mitigation Planning into one seamless program. The intent of this integrated program is to encourage beneficial partnerships and innovative uses of flood hazard and risk assessment data in order to maximize flood loss reduction."

According to Jack Quarles, Risk Map through collaboration with State, Local, and Tribal entities will reduce losses of life and property through effective local mitigation activities. These activities are enabled by quality flood hazard data, risk assessments and mitigation Identifying, planning by: assessing, communicating and mitigating the risk with a primary goal of providing a new study, or new detailed study, where either the old study was inconclusive or it never was studied.

**DFIRM 101 Workshop:** Diane Calhoun (dcalhoun@mbakercorp.com) and Dean Lee (dlee@mbakercorp.com) of the RMC -Michael Baker Jr. presented their planning for a series of workshops to be held on "digital FIRM's. Beginning October 1, 2009, FEMA will

One challenge which the Oklahoma East chapter has witnessed in Bolivia is that the poorest and most remote communities (the

> ones who need these projects the most) have neither the knowledge nor the means to develop these project proposals.

Working with students from the University of

Tulsa, the chapter is currently planning a site assessment trip, scheduled for May 2009, to the area of Cotani, about 30 miles (39 km) northwest of Cochabamba. An implementation trip to build the first three to four ecolatrines will follow in August, 2009. A series of 40 sustainable ecolatrines are being designed for use by the residents of this area, one for each of the 37 families, and three for public use at the local school, hospital, and library. At this time the sanitary practices of the population are proving to be harmful to the quality of life and are sub-par when compared to the conditions Americans take for granted.

Please consider being a part of this exciting deavor.

Whether you just wish to follow the successes and impact upon the residents of the projects,

or are interested in being a sponsor who believes, as we do, that supporting global engineering and global health is an investment in the future. The individuals of the EWB-Oklahoma East chapter would be happy to meet with you to provide

**EWB-OK** East will be traveling Cotani several times over the

next few years to build all 40 ecolatrines and any donation is welcome and tax deductible. A total of \$4000 is needed to complete the site assessment trip in May and another \$20,000 is needed for the implementation trip at the end of the summer.



#### Floodplain Management Never Rests

Oklahoma appears to be entering another drought period which makes this the perfect time to focus on your communities floodplain management program. Oklahoma experienced significant flooding in 2007-08. Time associated with these disasters consumed many hours away from the office and away from everyday operations.

The Oklahoma Water Resources Board and FEMA taught the week long "Managing Floodplain Development Through the National Flood Insurance Program" February 2-6. Thirty-six participants attended the weeklong training, a full class. This class was originally offered at the Emergency Management Institute in Emmitsburg, Maryland. Oklahoma lobbied FEMA and was awarded the opportunity to bring the class to Oklahoma. Since

1997, Oklahoma has offered the class every year in January or February and sometimes in August depending on supplemental CAP funds. OWRB is fortunate this year, thanks to supplemental funds we will offer the course on August 3-7, 2009. Twenty individuals on the February class waiting list can now be moved to the August class. The prestige to become a CFM has created a great demand to attend F273, Managing Floodplain Development Through the NFIP. If you are interested in attending, I recommend you register immediately at www.owrb.ok.gov, to guarantee a spot. The agenda for this class includes sections on outreach, risk determination and mapping, BFE considerations, regulations, the permitting process, substantial damage/improvement, insurance requirements, legal issues and problem solving. During this time of drought, take the opportunity to refine your communities floodplain management program by considering higher standards, identify structures in your community that experience repetitive flooding and consider buying them out.



sustained by a structure whereby the cost of restoring the structure to its before damaged condition would equal or exceed 50% of the fair market value of the structure before the damage occurred. DRT, when asked by a community, will assist in the substantial damage determination. It is very important to make this determination quickly after a flood and before individuals start repairing structures that might be substantially damaged. If a structure is substantially damaged, the structure must meet the local requirements that are currently in effect which include the lowest floor being elevated at least to the BFE. This is required to break the cycle of repetitive flooding. Please visit www.okflood.org for more information on DRT and other OFMA programs.

#### City Liable for Issuing Erroneous Building Elevations

A Lancaster County, Nebraska, judge has ordered the City of Lincoln to pay \$405,000 to three couples who were given city-issued building permits **but not told that their new** homes would be in a 10-year floodplain.

> According to court records, the City knew well before the families purchased the lots that the area was in a floodplain. A State Department of Natural Resources study of the area, completed and submitted to the City in January 1997, showed a flood-elevation level of 1,208 feet. City employees put the map in the subdivision's file at the Building and Safety office. But when the city issued building permits to the families between 1998 and 2003, each was given a floodplain elevation based on an older, and inaccurate, map from the Federal Emergency When Management Agency. notified of the true flooding risk in 2005, after the homes were built, the three couples brought lawsuits against the City.

Based on the testimony of expert witnesses, the judge took the following factors into account in determining the damages owed: (1) there is a distinction between a home with a dry basement and one that takes on water, regardless of whether it is in a floodplain; (2) a home in a floodplain would be valued differently than the same home in another location (for this area, testimony established the value of floodplain houses at from 5% to 19% lower than nonfloodplain houses); and (3) the frequency of flooding probably also would affect what someone would pay for a house.

OFMA Chair Clark M. Williams, CFM Press Release: Washington, DC - The U.S. House of Representatives Historian's office has determined that Congressman John D. Dingell (D-MI15) will become the longest serving House Member in U.S. history on February 11, 2009, passing Congressman Jamie Whitten from Mississippi. An earlier report by the Congressional Research Service (CRS) indicated that the Congressman would break the record on February 14, 2009, but the Historian's office and CRS reviewed the findings again and found a mistake in the count of days served by Mr. Dingell.

"I've made a couple of math mistakes in my day, so I can hardly blame the people that came up with the original number," Dingell said. "I'm just glad the House Historian's office found the error and Congressional Research Service worked with the historians to get it

right. CRS also does tremendous work and we have great respect for their research.'

Coming from Michigan, a state blessed with the Great Lakes, Congressman Dingell understands the importance of the Lakes to Michigan, as well as our Nation. Michigan owes its tourism industry to the Great Lakes – people come from around the country to recreate, hunt, fish and relax. The Lakes as a transportation system provide Michigan and the Nation with the means to be a manufacturing powerhouse. That is just one of the reasons the Congressman has made clean water one of his top priorities, playing an integral role in the 1972 Clean Water Act. OFMA recognizes the impact Congressman Dingell has had on legislation that not only effects Michigan, but that of Oklahoma, OFMA and the Nation as well.

#### Gas Drilling Update: An Industry Setback in Utah, Plus an **Overview From FLYP Media**

A U.S. District Court judge put the brakes on a 110,000-acre last-minute sale of federal lands for natural gas drilling in Utah last week, adding

another voice to a chorus of concerns over the environmental prudence of the Bush administration's energy policy. The judge, Ricardo M. Urbina, found that the Bureau of Land Management's management plans and environmental analysis for the lands that border Arches National Park and other significant scenic areas failed to adequately study air pollution and other impacts. His decision to stay the highly contested sale, which took place Dec. 19, will allow the court time to fully evaluate a lawsuit brought by environmental organizations challenging the sale.

The ongoing saga in Utah is one of several unfolding around the country as natural gas development accelerates amidst concerns that it may be harming water and air quality. ProPublica has been closely following these developments [1], and Flyp [2], an online multimedia magazine, has published an expanded, interactive version of our coverage. It includes exclusive conversations with a former director of the Bureau of Land Management and an industry spokesman, a slideshow, and a graphic explaining the drilling process known as hydraulic fracturing.



AUSTIN, Texas -- Thousands of Texans who are rebuilding their homes and their lives after Hurricane Ike are being helped by flood insurance payouts.

Congress established the National Flood Insurance Program (NFIP) in 1968 with two goals: to protect communities from potential flood damage through floodplain management and to provide people with flood insurance. Flood insurance, which is administered by the Federal Emergency Management Agency (FEMA), is the best protection that residents and businesses have against the devastating financial losses that floods can cause.

"By the numbers" information for the National Flood Insurance Program includes the following:

- 5.6 million was the number of policies in force nationwide as of September 2008.
- \$1.2 trillion was the amount of NFIP coverage provided by those policies.

- 504,409 was the number of policies in force in September 2008 in the 34 Texas counties eligible for federal disaster assistance to individuals, families and businesses in connection with Hurricane Ike.
- \$58.1 billion was the amount of coverage provided by the NFIP policies in those 34 counties.
- \$1.8 million was the amount of insured flood losses in Texas in the 10 years from 1998 through 2007.
- \$7,800 is the estimated cost of a flood that is 2 inches deep in a single home.
- 30 is the number of days in the waiting period for a flood insurance policy to take effect.

For decades, the National Flood Insurance Program has offered flood insurance to homeowners, renters and business owners, with the one condition that their communities adopt and enforce measures to help reduce the consequences of flooding.

#### From the Desk of the Executive Director

Alas another year is passing quickly. The OFMA Board, Committee Chair and invited guests just completed the 2008-2009 Strategic Plan Retreat. The Retreat was held at the Cherokee Nation Hotel in Catoosa, Oklahoma on January 22 - 23, 2009. This year's planning session was one day shorter than in past years. The Strategic Plan Retreat was moderated by Bill Smith, Past All of the OFMA officers - Clark Williams (Chair), Ellen Stevens (Vice Chair), Carolyn Schultz (Treasurer), and Amy Brandley (Secretary) were present. In addition - Ken Morris, Executive Director, Gavin Brady – State NFIP Coordinator, David Cross - Region 2 Representative, and Clint Strawn - Region 4 Representative. Many of our Committee Chairs were also present including Cecil Bearden -Mitigation, Omeed Mollaian – Membership, Joe Remondini – PDCC, Joe Robinson – Education, Bill Robison - Mapping, and Ana Stagg Legislative.

The Retreat included a brief review the Constitution and Bylaws, Vision and Mission Statement, and the past year's Strategic Plan and current OFMA Program activities to evaluate if changes were necessary or needed and then focus on the Vision for the 2008-2009 OFMA term of Chair Clark Williams.

A summary of the result of the Retreat was as follows:

- The DRT is now funded in part in part by FEMA CAP funds and will be fully operational for the upcoming spring and fall flooding Bill Smith, DRT Coordinator is proceeding forward with notification letters to all communities and planning the equipment purchases as funds allow.
- The OFMA Board voted, based on the detailed discussions and evaluation during the Retreat to increase dues beginning at the 2009-2010 OFMA year from \$30 to \$50 per individual member, Corporate membership will increase from \$100 to \$150 and Agency membership will increase form \$50 to \$75. A more

detailed explanation of the dues increase will be forthcoming in a letter from the Chair.



- · A volunteer, Christy Blair (daughter of Marsha Blair, FPA for Slaughterville) has stepped forward to assist OFMA with seeking Grant funding for ongoing projects, such as the DRT, mapping communities that currently have no floodplain maps but have designated SFHA's.
- OFMA is going to solicit university students to become active in floodplain management, attend OFMA conferences, and perhaps create Student Chapters at the various state universities.
- · Additional training is planned in coordination with OML, OEM, Circuit Engineering Districts, Insurance Agents Associations and Realtors Associations to assist in floodplain management activities, regulations, etc.
- Each Regional Representative will host a

monthly luncheon in their respective regions for training, networking, communication of OFMA activities, etc.

- More discussions on publishing the BFE more frequently and more timely is likely.
- The OFMA webmaster, Michael Couch, is planning an OFMA blog to assist with communication between the OFMA Board and OFMA members and for members communicate with each other.
- OFMA will evaluate "Pay-Pal" for payment of conference fees and on-line registration for the April 2, 2009, Spring Technical Workshop in Jenks, Oklahoma. If it is successful, it may be carried over for membership renewals and our annual conference registration.
- OFMA intends to prepare a detailed proposal to submit to OWRB to assist with portions of the Oklahoma Comprehensive Water Plan.
- A series of press releases will be developed for releases throughout the year for increased public outreach. Coordination with the local FPA is planned to ensure the releases are published.
- Two new brochures are proposed to be developed - one relating to Oil and Gas Permitting and the second relating to Availability of Flood Insurance and Requirements for Insurance on Public Structures.

After reflection of this year's Retreat it was decided to go back to a 2 and a half-day session October 14-16, 2009. The OFMA Board meeting is held during this time period too. If you are interested in attending the next retreat please contact me. Bill Smith did an excellent job this year and graciously agreed to facilitate the October Retreat. Thank you Bill!
