NFIP RATE AND COVERAGE CHANGES ANNOUNCED

According to the April 2009 Issue of News&Views by ASFPM, the National Flood Insurance Program is gearing up to Many of the changes—which change. were postponed from this May-are procedural while others are rate related. * The main changes, effective October 1, 2009, are summarized as follows:

- The basic insurance limits (also called the first-tier rate) are being increased for all categories of buildings and contents. For example, the basic limit on building coverage for a 1-4 family dwelling is going from \$50,000 to \$60,000.
- Rates are being raised again:
 - V zone rates will go up by the 10% maximum:
 - A zone rates will go up by the 10% maximum, except for AH and AO
 - X zone rates are going up by 8% (standard rates).
- Minimum deductibles are going up as well. There will no longer be a \$500 deductible option. The standard deductible for pre-FIRM policies will be * \$2000 (with an option of buying it down to \$1000). The post-FIRM deductible will be \$1000.
- be indicated on the declarations page ASFPM website, at...(see below) if grandfathering was used for rating.



- A new risk rating method has been developed for any property leased from the federal government identified as being on the river-facing side of any dike, levee, or other riverline flood control structure, or seaward of any seawall or other coastal flood control structure. A list of property addresses meeting this description has been provided to FEMA by the U.S. Army Corps of Engineers. Beginning October 1, 2009, these buildings will be charged actuarial rates. ASFPM Insurance Committee Co-Chair, Paul Osman, has been a champion in getting this measure enacted, because these buildings are problematic in Illinois, where he is the NFIP State Coordinator. Two new building types (and diagrams) have been added: "elevated on crawlspace" and "non-elevated with sub-grade crawlspace."
- WYO (write-your-own) companies will have to start reporting the source of the building construction date used in rating policies.

As part of this [Flood Map Modernization] program —in an effort to eliminate duplication of efforts and reduce costs— FEMA plans to discontinue the public distribution of paper Flood Insurance Rate Maps, Flood **Insurance Study** reports, and related flood hazard map products starting October 1, 2009.

NO MORE PAPER MAPS-BY ANA STAGG, OFMA COMMITTEE CHAIR

The Federal Emergency Management Agency (FEMA) continues the update and conversion to digital of the National Flood Insurance Program flood hazard map inventory (a.k.a. Flood Map Modernization Program). As part of this program - and in an effort to eliminate duplication of effort and reduce costs - FEMA plans to discontinue the public distribution of paper Flood Insurance Rate Maps, Flood Insurance Study reports, and related flood hazard map products starting October 1, 2009.

FEMA will provide communities where the flood hazard information is updated with an updated paper map to satisfy local regulatory requirements for a paper map product - provided that such change occurs before October 1, 2009. For all other requests, FEMA will distribute digital Flood Insurance Rate Maps, Flood Insurance Study reports, and related flood hazard map products in place of the paper versions.

Over the past several years, FEMA has introduced new digital products including digital map images (the full-size FIRM Scans and letter size FIRMettes) and digital geospatial flood hazard data (the Digital Flood Insurance Rate Map (DFIRM) Database product and National Flood Hazard Layer (NFHL)). These digital products now make

up the vast majority of the flood hazard information distributed by FEMA and are equivalent to the paper maps for any official activities under the NFIP.

FEMA will discontinue the distribution of paper maps and study reports beginning with map update projects where the letter of final determination is issued on or after October 1, 2009. The letter of final determination is issued six months before new flood maps become effective for NFIP regulatory purposes.

FEMA will continue to provide digital flood hazard data products for Internet download, on CD-ROM, and via Web Mapping Service. Federal, State, and local government customers that have been receiving paper products will now receive

digital flood hazard maps and data, and continue to be exempt from fees.

FEMA states that this change will allow the realization of significant cost savings in the map update process by eliminating the need to generate large format film negatives to support offset printing. It will also save the cost of printing and distributing the paper maps to fee exempt customers. This change simplifies the products available depicting flood hazard for a location.

The FEMA Map Service Center provides complete information about the digital flood hazard data products, free tools, and easy-to-follow instructions for using them at http://msc.fema.gov.

ARE YOU READY FOR THE NEXT FLOOD-BY GAVIN BRADY, NFIP COORDINATOR

As we enter the season that usually brings Oklahoma its greatest probability for flood, I ask you one question, "Are you Ready"?

The OWRB and the Oklahoma Insurance Department sent out a mass press release acknowledging March as "Flood Insurance Month". As most of you are aware, it takes 30 days for a flood insurance policy to take affect so now is the time to purchase a policy before the April/May rains begin.

In Oklahoma, most significant flooding has occurred 11 days either side of Mother's Day. Individuals living in the floodplain have a 26% chance of flooding during the 30 year mortgage and only a 6% chance of fire yet most have a homeowner's policy covering fire

while only 11% have a flood insurance policy. Floods caused an estimated \$2.4 billion in property damage last year and that number continues to rise. Ask your local insurance agent about flood insurance or call the National Flood Insurance Program (NFIP) at 1-800-720 -1090 and speak to a representative. You can also go to www.floodsmart.com to find valuable information on flood insurance.

Things you can do before a flood should include determining where the floodplain is in your area, plan and practice an evacuation route, have an emergency supply kit (see floodsmart), have check valves installed in the sewer traps of your home or business to prevent floodwaters from backing up

sewer drains or at least use corks or stoppers to plug shower tubs and basins.

During the flood always be prepared to evacuate however remember never to drive in floodwaters...Turn Around Don't Drown. Have flashlights, battery operated radio or television and bottled water close at hand. Fill the bathtubs, sinks and any jugs with clean water in case the communities water supply becomes inoperable or contaminated. If it appears that water will eventually enter the house, turn off all utilities at the main valve switch and close the main gas valve.

After the flood it is important to remember that anything touched by floodwaters is contaminated and

should be sterilized before using again. Upon entering a house that was flooded, wear sturdy shoes so nothing will puncture through. Use battery operated flashlights.

Hopefully by now each of you are aware of the Oklahoma Floodplain Managers Association (OFMA) Disaster Response Team (DRT). Each Floodplain Administrator in the State of Oklahoma should have received a letter from me concerning the DRT. OFMA is once again a leader in the nation; as this is the only known volunteer disaster response team of its kind in the nation. I will be presenting at the 2009 ASFPM National Conference, so OFMA will once again be on the "cutting edge" of new innovation.

The purpose of creating the OFMA DRT is to assist our neighboring communities in times of flooding or other natural disasters. OFMA DRT members would volunteer to

go into Oklahoma communities (cities, towns, counties) that are about to or just have had a disaster and assist the local Floodplain Administrator (FPA) and community staff to deal with necessary tasks to evaluate flood damage or other natural disaster damage. This action would occur from the imminent time of disaster until a Federal Disaster Declaration occurs and Federal/State involvement is initiated under the Federal Declaration.

Currently we have 34 Volunteers. We added seven more during our first training session that was held following the OFMA Spring Technical Workshop.

We have distributed the

OFMA DRT kits, shirts, jackets and hats. For those who were not there at the first training session, we will have more contact soon and I will get your OFMA DRT equipment to you.

Please be ready to respond. Also, please keep your immunizations current because if we go on disaster response we do not know the type of situation we will encounter. Thanks for your volunteerism!!
