

## Common Construction Site Problems & How Solve Them

Oklahoma Department of Environmental Quality





#### Procedure

- DEQ desires compliance with our regulations for environmental protection and public health.
- Inspections are primarily driven by complaints but can also come from referrals, routine inspections, and environmental emergencies.
- Initial inspection- 14 days to comply
- Non-Compliance will result in Notice of Violation (NOV)
- Continued Non-Compliance will require a Consent Order (administrative penalty)
- Settlement Conferences if requested by permittee: frank and honest discussion

#### **Most Common Problems**

- Failure to implement temporary or final stabilization (dust generation).
  - "Fugitive dust" is an air quality term.
- Best Management Practices (BMPs) not properly installed and/ or maintained.
- Renewal Notice of Intents (NOIs) not submitted for coverage under the 2022 OKR10 General Permit.



# Problem: Stabilization (Dust Generation)


- Many construction sites, especially residential development sites, disturb large amounts of land at a single time.
- Development gets delayed for some reason and construction activity ceases.
- A large bare area of land is left exposed to stormwater, discharging large amounts of sediment of site during rainy seasons and creating dust issues during dry seasons.





# Solution: Stabilization (Dust Generation)

- The biggest contributors to dust generation, is unmanned construction sites that have not properly implemented stabilization measures.
  - OKR10 States, "Initiate the installation of stabilization measures immediately in any disturbed areas on any portion of the site where construction activities have permanently ceased or will be temporarily inactive for 14 or more calendar days. 2. Complete the installation of stabilization measures as soon as practicable, but no later than 14 calendar days after stabilization measures have been initiated, or seven calendar days if you discharge from a high priority construction site."





# Solution: Stabilization (Dust Generation)- Continued

• If dust remains an issue during active construction, water trucks or other dust suppression techniques should be used to prevent pollutants from being discharge into surface waters.



### Problem: BMP Implementation & Maintenance

- Improperly installed and managed BMPs is the most common problem found during construction inspections.
- Often installed and then forgotten.





## Problem: BMP Implementation & Maintenance (Continued)

• They are often not installed within the requirements listed in their design plan and Stormwater Pollution Prevention Plan (SWP<sub>3</sub>).





### Solution: BMP Implementation & Maintenance


- Maintaining regular inspections of BMPs at the construction site and identifying problems when they arise is the best way to ensure that all BMPs are properly installed and maintained.
- OKR10 Permit states, "All control measures must be properly selected, installed, and maintained in accordance with the manufacturer's specifications and good engineering practices. If periodic inspections or other information indicates a control has been used inappropriately or incorrectly, the permittee must replace or modify the control for site situations"
- Inspection reports should be through and document any deficiencies found and note corrective actions that are needed.

#### Problem: OKR10 Renewals

- The 2017 OKR10 General Permit expired on October 17, 2022 and the 2022 OKR10 General Permit going into effect on October 18, 2022 (modified effective date of April 1, 2023)
- OKR10 Permit States "Existing operators of on-going construction projects/activities that have active authorizations for coverage under the 2017 CGP coverage upon its expiration must submit an NOI within 90 days of the effective date of this permit. Authorization under the 2017 permit will be administratively extended for a period not to exceed 90 days from the effective date of this permit. The existing SWP3 must be updated to comply with this permit prior to the NOI submittal"
- Biggest issues with facilities who obtained authorization under the 2017 permit shortly before it expired.

#### Solution: OKR10 Renewals

 Need to inform all permittees of requirement of renewal of OKR10 Permit



#### Translocation

#### **Effects**


- Loss of topsoil

# Incorporating Resiliency Aspects Through Technology and Change in Approach

- Low Impact Development (LID) Concepts
- Green Infrastructure (GI) in wider use
- Technology theoretical and applied uses
- Regulators should set the pace along with State Agencies (such as ODOT and OTA) and Municipalities
- Change in attitude is necessary

## Things to Consider

- Changing times require changing procedures
- Requirements must be "reasonable". Can a contractor reasonably be expected to do something?
- What modifications can be made to policy and procedures?
- Are there other ways of doing things?
- Do Permit requirements fit the times.
  - Caveat; OKR10 expires on October 17, 2027)
- Real Reasons (no rationalizing).



### Paradigm Shift

- Reframing a situation
- Move to a different picture frame
- How can that reframing affect outcomes?
- The possibilities are infinite



## SUSTAINABILITY AND PARADIGM SHIFTS

- Sustainability
  - the ability to meet the needs of the present generation without compromising the ability of future generation to meet their needs
- Paradigm
  - a model or concept that is accepted by most people in a society
  - it may be a process, idea or set of data

### Examples

- Enforcement-Top Down
- Outreach (optional: if you want to)
- Traditional enforcement (legal procedures)

- Collaboration (Amway)
- Outreach (waive one year's fee)
- Inspectors have a ticket book; (modest environmental impact)
