### **2025 Annual Conference Update**

The 2025 conference at the Reed Center in Midwest City was a standout Annual Conference. We appreciate everyone who contributed- the OFMA Board, speakers, sponsors, and attendees. Each of you play an essential role in making this event possible and improving the quality and member experience year after year. We hope the education sessions were beneficial and that everyone was able to take advantage of networking opportunities!

The conference opened with a ceremony presented by the Midwest City Junior ROTC, followed by welcoming remarks from Midwest City Mayor Matt Dukes. OFMA Chair Jesse Beck delivered an opening statement focused on the connections we have within our communities challenging all of us to recognize the value of our connections and the potential to impact not just our communities but the world! Jesse extended a warm welcome to all fall conference attendees.

Monday's keynote session highlighted the critical role of flood warning systems in storm preparedness and post-event model validation, presented by David Key of ESP Associates and Brandon Claborn of WSB. Chad Berginnis then provided a comprehensive update from ASFPM, including upcoming training opportunities and available resources. Jonathan Phillips shared the latest Oklahoma NFIP Program Report, and David Williams concluded the morning plenary with an update from the U.S. Army Corps of Engineers.

Monday afternoon included fourteen different presentations in three tracts on topics including Why Developments Flood, NOAA Atlas 15 and Temporal rainfall Distributions, and Rub-a-Dub-Dub: Detention with a Tub. Navigating Floodplain and Drainage Challenges for Transportation Projects, Collaboration and Community Engagement in Moffet, and Stormwater Management for Design Engineers. Impacting Lives by Hard Armoring against Extreme Weather Events, Supporting Community Resilience: Leveraging USACE FPMS Technical Services for Floodplain Management, and Advancing Flood Risk Mapping in Oklahoma: A 2D BLE Modeling Approach through FEMA CTP Program. Floodplain Map Revisions and Hydraulic Modeling: Common Mistakes and Steps to Avoid, Stormwater Utilities: Getting off the Funding Roller Coaster, Back to Basics in a Time of Changing Funding, From Storm to Impact: Using 2D Modeling to Understand the July 2025 Texas Flood, and an MS4 Round Table Discussion.

To cap off the first full day of the conference the new members and young professionals social was hosted by Bill Smith and Freese & Nichols. This was followed with the annual Vendor Social hosted by WSB with food sponsored by OFMA. Attendees enjoyed bowling, arcade games, laser tag, and karaoke.

Tuesday began early with OFMA Committee meetings, followed by Regional Representatives Meetings and an update from OEM's Director, Annie Vest.



- 1. What are the 3 primary tools in the FPA Tool Box?

#### Answers:

- 1. Ordinance, FIRM Panels, and Flood Insurance Study
- 2. Cleanout Ditches and Culverts during the "dry" winter months
- 3. Yes
- 4. Yes. Retain a consultant to review
- 5. They can, but it is not required. When FEMA issues the LOMA
- 6. LOMAs have to be revalidated during a map revision process. It is the FPAs responsibility to assure they are revalidated.
- 7. You should and you can just email wbsmith@hisinc.us and a Sample Resolution and Sample Letter will be provided.
- 8. Provide Floodplain information (limits and elevations), emergency access routes, possible evacuation needs of individuals in the SFHA, assist with post disaster damage assessments
- 9. Yes, the EM assesses damages for the Governor's proclamation of a State Disaster and request for Federal Disaster. The FPA assesses the same damages for SD/SI, issues permits for repairs and determines compliance.
- 10. When SD is greater than 50% of the Fair Market Value of the structure.
